

6.1 Emergency treatment:

Cut off the power and fire source, leave quickly to safety place of the leak contaminated area personnel, cut off the pollution sources as soon as possible, prevent into the sewer. Remove spilled materials with protective equipment (protective glasses and protective gloves).

Do not inhale the gas as much as possible.

Moreover, avoid touching with as much as possible.

Recycling the leakage liquid to an airtight container carry to the waste disposal sites, cleaning field of residual liquid with inert material, such as sand and so on.
